DORES' Report: Liz Hartmann: The State Records Committee is attending to have a special meeting on Thursday, July 20th. DORES RMS is continuing to work on updating local schedules. They would appreciate any feedback, suggestions, and information on any new potential record series.

Additionally, DORES is continuing to work on BOE records with schools and in conjunction with the State Archives.

State Archives Report: Donald Cornelius, Archivist: The NJ State Archives is pleased to announce that we have hired Carmen Biempica as our new Archivist in Collections Management, and she has started just this week! Carmen comes to us after spending the past eight years in Tampa, Florida, as a Supervisory Librarian in the Hillsborough County Public Library System. In addition to her regular library duties, Carmen also supervised the Florida and History Genealogy Library. She was responsible for accessioning and developing new archival collections, as well as processing those existing collections in the library. In her new position, Carmen will be assisting me in all of the aspects of collection management: appraisal, archival review, accession, arrangement, and description. I am sure she will help out on reference, too, once she gets her feet under her. Please welcome her to CARMA and wish her well in her new position!

Recent new additions to the collections include two returned laws. One is from 1777, "An Act to Exempt Ten men to be employed at the Union Saltworks in the State of New Jersey from service in the Militia". The other is from 1811, "An Act to Incorporate the Franklin Company." Both of these laws were returned from auction houses. One was an intervention of a sale; the other was a voluntary action by the auction house after their due diligence provenance search.

In other collection news, we are working on processing the Naturalization Books of Union County, from 1906 to 1948. When that is complete, we will integrate that collection with our existing pre-1906 holdings of that county, and we will then add it to our list of counties for which we provide reference service to the naturalization paperwork.
