#### **Internet Security**

Detective Charles Allen and Sergeant Stan Field Cyber Crimes Unit New Jersey State Police

The Identity Theft Act passed about a year ago requires problems to be reported to the State Police, which has 1,000 in uniform, 2,000 not. The Cyber Crimes Unit was established as the High-Tech Crimes Unit in 1997. Now it also includes the Investigations Support Unit which deals mainly with crimes against children.

Types of crimes the unit addresses include ebay fraud, online prostitution, network intrusions, hacking, et al.

ID theft continues to be mostly from paper documents, not computers. IDs are stolen from garbage, mail, insider sources in companies, purse/wallet thefts, as well as Internet phishing. People steal credit card numbers from gas stations and restaurants; the card is run through a skimmer and sold for \$100 per person to an ID dealer. People also acquire ID info legally from newspapers, obituaries, Social Security Death Index, employment records, and other sources. For \$500, you can pay a service, such as zabasearch.com to provide you with virtually any information about an individual in the U.S.; this information is all from public sources.

It is not illegal in New Jersey to post social security numbers and other personal information on web sites. It is only illegal if one gets money one is not entitled to using such information.

There are three credit companies: Equifax, Transunion, and Experion. You can get your credit report free from each of them once a year. It is recommended to contact them every four months, one after the other, so you get three free reports per year. You can also, for a fee, place a Security Freeze on your information, so that they will not release reports to anyone without your permission.

If you are a victim of a credit card fraud, you should tell your local police who will give you a report with a report number. You may need this number so that you don't have to pay fraudulent bills.

If you are a victim of hacking, you don't have to report the crime if the files were encrypted.

Tips: encrypt sensitive information used in e-mails; shred critical mail; use corded phone when ordering merchandise using a credit card; protect wireless computers from hackers; report Internet fraud to the Internet Crime Complaint Center at http://ic3.gov

#### Jim Brown, Senior Vice-President, AmCAD

In 2006, 8.9 million Americans were victims of identity theft crimes. The average value per victim was \$6,383, the average cost to the individual was \$422, and the average time for the consumer to rectify the problem was 40 hours. 10% of the theft occurs from government records. Recently, 45 million credit card numbers were stolen from TJ Max alone. In Philadelphia, hundreds of deeds have been transferred illegally without the owner's knowledge and the properties sold by the thief; the city is now passing a law requiring notification of owners when a deed is transferred. Some government web sites around the country are being shut down. In Texas, public access terminals for title searchers were closed, despite protests from title searchers; recently, they were restored for 60 days until the state passes a liability statute. Virginia passed a law that social security numbers have to be eliminated from web sites by 2010. In Bergen County, DataTrace requested records with an OPRA request; Bergen refused unless DataTrace is willing to redact the social security numbers. DataTrace is appealing the ruling.

AmCAD uses software that searches using OCR for patterns such as social security numbers, birth dates, fingerprints, and photos, and redacts them automatically. The software is about 90-95% accurate when used without checking. When a double blind manual review is used, accuracy increases to 99.95%. The client gets a redacted copy; the original is not altered. Camden County used AmCAD to check six million images with five different fields redacted. In Arizona, Privacy Advocates targeted Maricopa County, where addicts were using mortgage records to get credit cards in the names of property owners. AmCAD scanned 83 million images and is redacting them at the rate of one million per day at their facility in Illinois, where they have several hundred employees.
